

## **Hunting Terms and Conditions**

- Client/s agree to pay a **50% deposit to confirm booking**. This deposit must be paid within 2 months of making your booking. Your hunt will not be confirmed until this deposit is paid.
- Client/s must return their **Guest Information Form** at the same time as their deposit being paid to confirm their booking.
- **Declaration of Acceptance**: We are happy to transfer your hunt to a rescheduled date within the same year that the booking was made for.
- The remaining balance for your hunt must be paid at the finish of your hunt (onsite) before leaving.
- Payments can be made with either credit card, cash or bank deposit please note: if processing with international credit card there is a 3.6%
  processing fee that will be at the clients cost.
- Clients must abide by companies' written or verbal policies/instructions at all times. Failure to do so will forfeit your hunt and fee and the company has sole discretion in this matter.
- Metanoia Ventures will ensure a highly skilled guide guides the client.
- No alcohol or drugs are to be used while hunting with Metanoia ventures. Alcohol only to be consumed in moderation once hunt is finished for the day and rifles are put away.
- If Metanoia Ventures cancels the trip for any reason (apart from weather) the deposit money paid by client will be transferred to hunt at a different time
- Metanoia Ventures will take all reasonable steps to assist the client in the
  hunting and shooting of all game booked for their hunt, but due to the
  nature of New Zealand conditions, Metanoia Ventures cannot guarantee
  that the client will successfully hunt and harvest or obtain trophies of the
  quality and/or a booked game species. Metanoia Ventures will make every
  effort to adhere to hunting and shooting schedules arranged during the
  specific hunting time period, but it reserves the right to alter the schedules
  when alterations may be necessary due to changing weather conditions or
  any other changing conditions.
- If an animal is wounded by an arrow or bullet it counts as a taken animal, Metanoia will do their best to track and recover the animal, but please note sometimes they can be lost.
- If a shot on an animal is badly placed and the client wishes for the guide to take a follow up shot, the guide will only shoot if asked by the client.
- All animals/trophy's hunted and taken remain the property of Metanoia Ventures until the hunt is paid in full.
- **Prices do not include** Taxidermy, off ranch activities, alcohol, taxidermy export documentation, crating and shipping of trophies, taxes and levies on exporting of trophies, personal travel and/or medical insurance.
- The quote provided is valid only for the dates specified. All meals at the lodge are included within your quoted dates. Any additional meals, drinks, or accommodation beyond the lodge and dates outlined in your quote will be at your own expense. Metanoia Ventures will not be liable for issues

- related to incorrectly booked flights, delayed flights, or any travel disruptions.
- All Metanoia Ventures staff must be treated fairly and with respect at all times. Guests are expected to acknowledge the team during safety briefings and accept any necessary changes to plans for safety reasons. The well-being of both guests and staff is our highest priority. We operate an inclusive and accepting business and expect all guests to adhere to these values.
- Metanoia Ventures will base your trip itinerary and activities on the
  information provided in the guest information form. Should guests fail to
  disclose any prior health or fitness conditions, Metanoia Ventures will
  not be held liable if the trip cannot proceed as initially planned. In such
  cases, the responsibility lies with the guest for failing to provide accurate
  information. The trip will be considered non-refundable, and full charges
  will apply upon departure.
